Greetings from B.PAC!

Under your leadership, Karnataka state became the first among the other states in the country to direct transfer benefits to the farmers' account under state funded schemes pertaining to Agriculture Dept. 'Parihara'- the program of Direct Benefit Transfer(DBT) has ensured the subsidies reach the targeted individuals.

The Agriculture and revenue Department together worked in crediting a subsidy amounting to Rs 671 crores to the bank accounts of farmers through Direct Benefit Transfer (DBT) scheme whereby a farmer's identity is verified through his/her Aadhaar number.

B.PAC supports Government's initiative which streamline subsidy for farmers and reduce corruption and delays and the proposes to extend DBT to all state funded schemes.

B.PAC during the public hearing made a submission to the Hon'ble Karnataka Electricity Regulatory Commission (KERC) to direct ESCOM's to remit subsidy amount per IP Set be transferred to the farmers directly under the Direct Benefit Transfer (DBT) scheme.

The Commission took note of our suggestion and has viewed in its final order that "implementing the suggestion of direct remittance of subsidy to the farmers would encourage metering of the IP Sets enabling proper accounting of energy and also facilitate accurate computation of losses in the distribution system. The Commission notes that the Government of Karnataka would have to formulate suitable policy in the matter."

It is estimated by the Commission; Government of Karnataka will pay over Rs. 9938 Crores towards free supply of electricity to 26.57 lakhs IP sets up to and inclusive of 10 HP and 29 lakh BJ/KJ households to ESCOM's during FY 17-18.
