Analysis Of Candidates in Bangalore with Criminal Complaints Filed Against Them

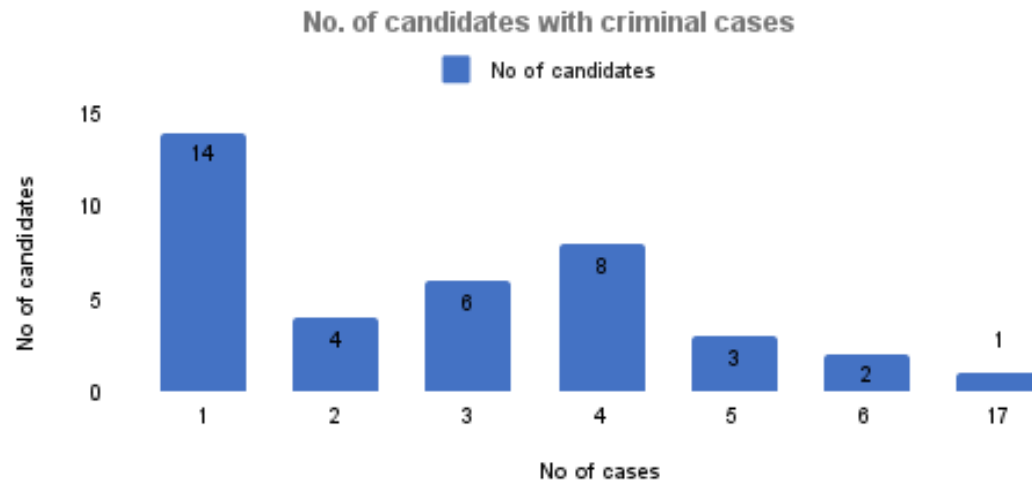
In light of the Karnataka Legislative Assembly Elections 2023, DAKSH in association with B.PAC has analyzed the self-sworn affidavits of 115 candidates contesting in Bangalore from the four major political parties and a few independents. The affidavits were available on the ECI website (<https://affidavit.eci.gov.in/>).

We found that **38 of the 115 candidates we analyzed had criminal complaints filed against them**. While some of them are the stage of investigation, most are pending before the Courts.

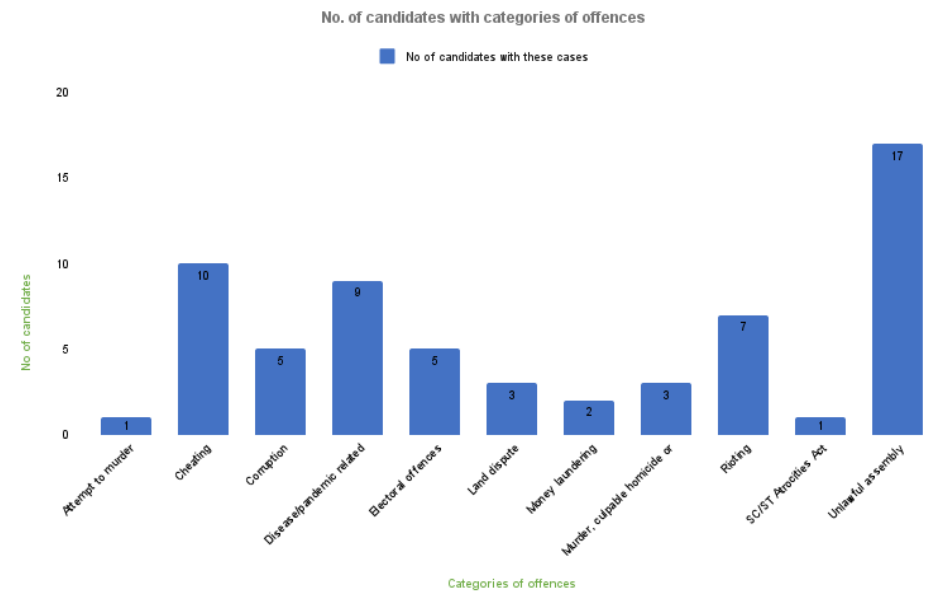

- 6 candidates have 4 cases registered
- 2 candidates have 6 cases each registered
- 1 candidate has 17 cases registered

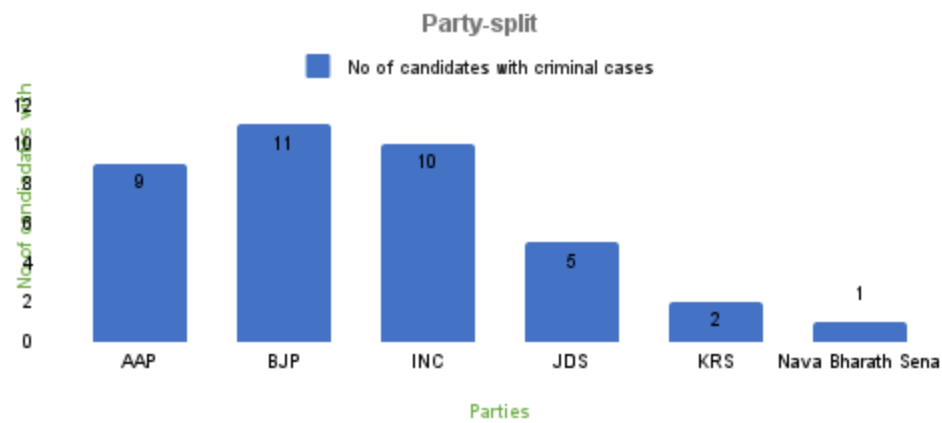

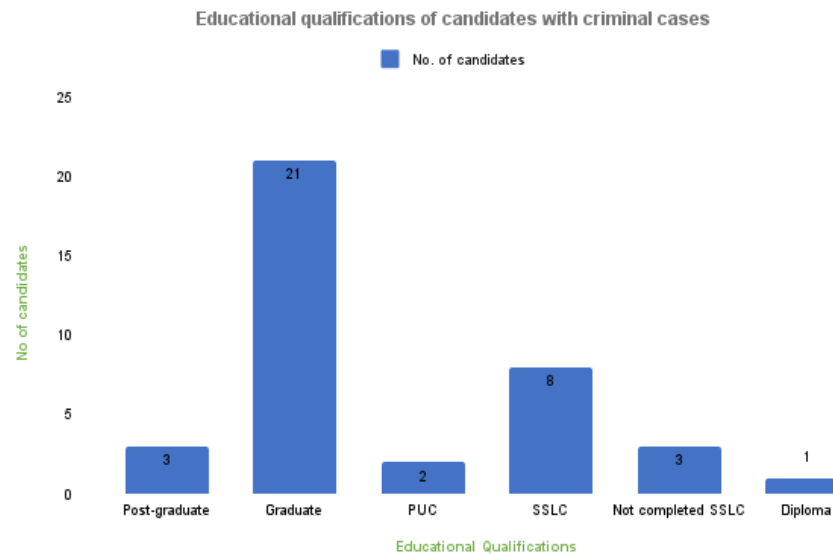

Education and Gender

- Of these 38 candidates, 3 candidates have a post-graduate degree, and 21 candidates have a graduate degree. Of the remaining, 2 candidates have only studied up to 12th standard, 8 have completed SSLC and 3 have not completed SSLC. Only 1 candidate has a diploma.
- 2 women candidates and 33 men out of 35 have cases registered against them.
