B.ENGAGED

A Webinar Discussion on Delimitation

B.PAC hosted a [webinar](#) titled "The Basic Grammar of Democracy: Concepts and Principles in Delimitation," featuring Mr. Lalit Panda, Senior Resident Fellow at the Vidhi Center for Legal Policy. This dialogue explored the fundamental aspects of democratic processes and the critical principles guiding the delimitation of ward boundaries within Indian cities. The session aimed to shed light on the essential principles of delimitation, particularly in the context of the upcoming delimitation of constituencies for the Lok Sabha and State Legislative Assemblies, which will be based on the first Census after 2026.

Urban Charchegalu: Managing Urban Green Spaces

On 1st June, at the onset of the monsoon season in Bengaluru, B.PAC hosted a [session](#) under the initiative 'Urban Charchegalu' with Mr. B. L. G. Swamy,

Deputy Conservator of Forests, BBMP. The session, titled 'Challenges and Solutions in Managing Urban Green Spaces,' highlighted the importance of citizen participation in greening Bengaluru. Many volunteers are eager to plant saplings across the city, but there is often confusion about which species to plant and where to obtain them. The session aimed to address these concerns and offered valuable insights.

B.SAFE

A Visit to the National Youth Conference

B.PAC, represented by Ms. Siri T. K., B.SAFE Program Lead, participated in the National Youth Conference titled "Cities for Youth," a two-day event held in Jaipur and organized by SafetyPin on 9th and 10th May. The conference brought together over 100 young participants from across India to share their experiences and insights on urban well-being. The team engaged in meaningful conversations about amplifying young voices in urban design and planning, and they had the opportunity to help identify priorities and gaps in city planning and design.



B.SAFE Constituency: Phase 3

B.SAFE Constituency Phase 3 will begin with a Public Place Safety Audit of Govindrajnagar and Vijayanagar assembly constituencies. This initiative follows successful audits in Mahadevapura, Malleshwaram, Hebbal, and Dasarahalli assembly constituencies. We have commenced the selection process for B.SAFE Ambassadors, involving application review and in-person interviews. The initiative is scheduled to launch on the ground in July. This time the audit will include the collection of the latitude and longitude of approx 500+ locations under 6 categories of public places in the two constituencies, enabling precise mapping and targeted safety interventions based on spatial analysis.

B.MOBILE

Updates on the 'IRR Street - Standstill to Active' Initiatives

This initiative is one of B.PAC's flagship projects, launched in 2023, aiming to improve bus connectivity and pedestrian walkability along the IRR, alleviate traffic congestion, and create lively streets.

Audits and Recommendations

After conducting multiple audits, surveys, data analysis, and drawing inferences, we presented our recommendations to the concerned government departments and have been collaborating with them to implement changes on the ground.

Collaboration with Traffic Police

In a meeting chaired by Mr. M. N. Anucheth, Joint Commissioner of Police (Traffic), B.PAC shared these recommendations with Inspectors and Sub-Inspectors of five traffic police stations and ACPs of the South East and Central subdivisions.



Joint Site Inspections

We organized joint site inspections for road markings and traffic calming interventions with the BBMP Traffic Engineering Cell (TEC) East & South and the Bengaluru Traffic Police (BTP):

- **South East:** ACP, Adugodu and Madiwala Inspectors, from Madiwala Masjid junction to Sony World junction.
- **Central sub-division:** ACP and Ashoknagar Inspector, at Ejipura junction.
- **Ulsoor:** Sub-Inspector & JB Nagar Police, from Indiranagar KFC to the middle of Defence land.

Presenting Audit Findings

We presented the findings of these audits to Mr. BS Prahlad, BBMP Engineer-in-Chief, TEC, and RI team. These findings included recommendations on road markings and traffic calming, as well as audits of streetlights, bus waiting shelters, and kerb inlets. We also addressed issues of garbage, debris dumping, and hanging cables in a letter to the EIC.



Pedestrian Access Proposal

In a meeting with the BBMP TEC team, headed by Mr. Arif (EE, TEC), B.PAC presented the Domlur flyover pedestrian access proposal, incorporating inputs from Mayapaxis.

Implementation of Traffic Calming Measures

Supported by BTP and coordinated by B.PAC, BBMP TEC East implemented pedestrian crossings and stop lines at Ejipura junction and Indiranagar KFC Junction, and installed rumble strips near Indiranagar 14th and 15th main junctions. B.PAC and TEC East identified locations for traffic calming in the East zone, and the contractor referred to the relevant marking drawings developed by B.PAC, as advised by BTP.




Streetlight Audit

A streetlight audit was conducted at night by B.PAC with BBMP Electrical South AE and a contractor, from Madiwala Masjid to Ejipura Signal and Koramangala 80 ft. road.

We will release a report of our findings, on improving the IRR, in the public domain soon.

A Guest Lecture by B.PAC

On May 2nd, B.PAC participated in a three-day workshop titled 'Decoding Intersections,' organized by Compartment S4 and Thirty Cross, and supported by the Sustainable Mobility Network. The workshop was held for 20 Master's students in Urban Design from RV College of Architecture. Ms. Priyanka Krishnan, Research & Program Associate at B.PAC, was invited to present at the 'Learning from Practitioners' webinar. Her presentation, titled 'The Crossroad Dilemma,' shared valuable insights and learnings related to junctions and road

safety on the Inner Ring Road. Key topics included walkability audit observations, traffic signal audit inferences, the importance of makeshift safe pedestrian access during road construction, the impact of pedestrians being excluded from design considerations, and potential solutions. 

B.GREEN

Participation in a Virtual Panel Discussion on Bengaluru's Water Crisis

On April 23rd, team B.PAC participated in a virtual panel discussion titled 'Bengaluru Water Crisis: Challenges & Potential Solutions,' organized by BeST Cluster. The discussion focused on the scientific causes and potential solutions to the city's water crisis. B.PAC and 18 esteemed panelists including the BWSSB Chairman, Director of the Central Ground Water Board, scientists from IISc, professors, other experts, and civic groups attended the session. We provided insights into effective water conservation strategies and measures to prevent water pollution.



Meeting with the Bengaluru Climate Action Cell

On 31st May, we presented our work and its relevance to the Bengaluru Climate Action Plan in a meeting at the BBMP Head Office. The meeting was chaired by Special Commissioner for Forest, Environment, and Climate Change Management, Smt. Preeti Gehlot, IAS. During the meeting, potential roles for B.PAC in the Climate Action Cell's activities were discussed, paving the way for future collaborations in addressing climate challenges in Bengaluru.



SOCIAL MEDIA INITIATIVES

Menstrual Hygiene Day: Period Poverty Awareness

On Menstrual Hygiene Day, May 28th, we launched a campaign to raise awareness about period poverty, a critical global issue. Our social media campaign featured seven posts covering a range of topics, including the need for adequate provisions for girls and women in schools and workplaces, debunking period myths, involving men in the conversation, and promoting access to eco-friendly alternatives. The campaign also included a comprehensive [blog](#) that addressed all the primary aspects of menstrual hygiene and offered solutions to period poverty.

Draft Active Mobility Bill Awareness

In June, coinciding with World Bicycle Day and World Environment Day, we launched an awareness campaign highlighting the importance of the Draft Active Mobility Bill by the Directorate of Urban Land Transport (DULT). This draft bill provides legal provisions and rights to the most vulnerable road users, such as pedestrians and cyclists, and aims to restore equitable allocation of road space for sustainable urban mobility. Our eight-post social media campaign explained the significance of passing this bill and the resulting benefits, including reduced dependency on fossil fuels and motor vehicles.

Urban Forestry Awareness

The decreasing green cover in Bengaluru has become a compelling issue, especially given the rising temperatures and the intense summer of 2024. Addressing the issue of preserving and developing urban greenery is now imperative. The B.PAC Urban Forestry Handbook for Bengaluru highlights the importance of urban forests and offers solutions by recommending indigenous trees suitable for various space constraints. We built a [webpage](#) where the citizens can access the handbook in English and Kannada. Our four-post social media campaign discussed tree planting options for areas with low, medium, high, and no space availability, as suggested by the handbook.

Honouring the Environmental Changemakers

Bengaluru is renowned for its environmental warriors, driven by a strong sentiment to preserve the city's past glory. Celebrating these champions and spreading awareness about their ingenuity, tenacity, and dedication is crucial, especially as Bengaluru faces rising temperatures and a depleting green cover. Our social media campaign aims to honour these individuals. It includes eight posts, each highlighting a celebrated environmentalist from various domains of sustainability, namely Anand Raaj, Suresh Heblikar, Vani Murthy, Vishwanath S., Dr. A. N. Yellappa Reddy, S. G. Neginhal, Sharachchandra Lele, and Ramakanth N. S. With this campaign, we aim to inspire and reignite the passion for the environment, and nurture the progress of sustainable development.
